ASBESTOS ABATEMENT

CET's asbestos abatement professionals have completed over 10,000 successful abatement projects since 1988. The projects have entailed all types of materials requiring abatement including, but not limited to, sprayed-on acoustic ceilings, sprayed-on fireproofing, vinyl asbestos floor tile and mastic, linoleum, roofing materials, sheetrock, heating duct, pipe insulation (TSI), including underground pipe, and boiler insulation. All CET's workers and supervisors are Union trained by independent AHERA certified training centers. Laborers typically average over five years experience and supervisors typically over ten.

LEAD/LEAD-BASED PAINT ABATEMENT

All workers and supervisors are trained and certified for lead abatement and are registered with DHS. Abatement procedures include hand scraping, HEPA planing, media blasting, chemical stripping, needle guns and scarifying. The care in which these techniques are employed on architectural components such as doors, stair railings and windows sets CET apart.

MOLD ABATEMENT

The health effects and legal ramifications of airborne molds and fungi are major issues. CET provides the HazMat mold abatement procedures required in healthcare and educational facilities.

DEMOLITION

CET is unusual amongst demolition contractors in that we self-perform abatement, concrete cutting, and coring. The customer benefit is sole responsibility for all demolition tasks and one set of contract documents and one crew to oversee for their demolition scope.

TRANSPORT / WASTE HAULING

To increase efficiency and safety, CET owns and operates our own fleet of dump trucks, roll off trucks and waste bins. We are a licensed hazardous waste hauler and carry \$2 million of insurance with an additional \$8 million of umbrella coverage. We provide construction debris bin service to other contractors in Santa Cruz & Monterey counties

CORPORATE HISTORY

COASTWIDE ENVIRONMENTAL TECHNOLOGIES, INC. (CET) was formed in 1988 with the express purpose of abating asbestos and lead containing building materials in the central and northern California coastal counties.

Coastwide's professionalism increased demand for our services, leading to a major presence in abatement contracting with city and county governments, military installations, public utilities, universities, community colleges, public schools and industry.

Our scope of services has expanded over the years to become a one stop demolition shop providing abatement, selective demolition, concrete coring & cutting and building wrecking.

Much of our core staff has been with CET for over twenty years. That continuity of service matches the long-term relationships we have with our General Contractor and building owner customers. We manage the business for the long term and treasure the many long-term customers that rely on us.

Over the years our service area has expanded from the Monterey Bay area in the central coast down to San Louis Obispo, to the greater San Francisco Bay area and to the central valley.

One thing that has remained constant is our goal of providing high quality work, exceptional cleanliness, and close cooperation with our customers.

TECHNICAL CAPABILITIES

- Estimating
 - Practical Experience
 - CET's field management has over 100 years of combined practical experience. Major projects are estimated independently by our field managers and this estimate is used as a reality check against the estimators estimate.
 - Estimating Systems
 - *On-Screen Take-Off* is used to measure and calculate quantities for the job. During this take off, the project is broken into areas, which are used for developing the schedule of values and assisting change orders.
 - *Job Cost Estimator* is an internally designed application that totals the cost for each area from the takeoff (creating the schedule of values) and adds the incidental costs and markup to create the final bid value.
- Project Planning
 - CET assigns manpower at levels that ensures projects stays on track using the manpower estimates from *Job Cost Estimator*. CET's Project Managers have extensive experience in managing multi-year multi-million-dollar projects.
- Project Management
 - Documentation
 - To ensure compliance and streamline workflow, CET developed a proprietary data base that manages all project documentation from bid to billing. Key documents such as air district and OSHA notifications are integrated into the system.
 - Change Order Control
 - Change order requests, approvals and supporting documentation is part of the database. An approved change order generates timesheets specifically linked to the change order, greatly simplifying auditing of change order work
 - Billing
 - Schedule of values and change orders are integrated in our project management system, monthly billings are timely and understandable.
- Tradecraft
 - CET's supervisory and labor work force averages more than five years tenure. They are highly experienced in abatement and demolition tasks. They are backed up by the highest quality hand and power tools available. Each worker is issued his own kit of safe, sharp tools in good condition.

CET is certified Small Business Enterprise (SBE). We are signatory to Laborer's Int'l Union Local 67 (Abatement) and 270 (Demolition). CET carries \$10,000,000 (2,000,000 +8,000,000 Umbrella) of liability insurance CET is bondable for a large variety of jobs.

CET Supervisors and Laborers receive their initial and refresher training through the Laborers union. Typical training includes asbestos/lead, concrete cutting, OSHA (10) & (30), Confined Space, HazWoper, torch cutting, reach lifts, and other aerial equipment operation. Regular recurring safety training is performed in house on topics such as fall protection and electrical safety

Coastwide's supervisors are highly experienced, with a range of 5 -20+ years of field experience. Supervisors and laborers receive:

- Annual medical examinations.
- Annual fit testing for the use of respirators.
- Blood pathogen testing every 90 days for lead.
- First Aid and CPR training.
- Quarterly (or as often as may be needed) procedural and safety review classes.
- On site safety meetings at the beginning of each project.
